### The Bop Tots Club Terms & Conditions

#### **1. The Bop Tots Club membership**

1.1. K Sidell T/As Bop Tots ([Karen@boptots.co.uk](mailto:Karen@boptots.co.uk)) operates the website [www.club.boptots.co.uk](http://www.club.boptots.co.uk) and its membership scheme as a subdomain of <https://boptots.co.uk>

1.2. This page describes the terms and conditions on which we supply The Bop Tots Club memberships, and on which you become a member of The Bop Tots Club.

1.3. Please read these terms and conditions carefully and make sure that you understand them, before becoming a Bop Tots Club member. You should understand that by signing up to become a member, you agree to be bound by these terms and conditions. You should print a copy of these terms and conditions for future reference.

1.4. On the membership registration page there is a checkbox stating that you have read & accepted these terms & conditions, and consent to us processing your data in accordance with our privacy policy. If this checkbox is not ticked, please understand that you will not be able to become a member.

1.5. By becoming a Bop Tots Club member, you warrant that you are legally capable of entering into binding contracts and you are at least 18 years old.

1.6. We reserve the right to amend these terms and conditions at any time by giving you notice by posting the amended terms and conditions on our site.

1.7. After you register for a Bop Tots Club membership, you will receive an email from [club@boptots.co.uk](mailto:club@boptots.co.uk) acknowledging that your registration is complete.

## **2. Membership renewal & cancellation**

2.1. The Bop Tots Club Premium Membership is an ongoing subscription service, so your membership is continuous and renews automatically until you cancel it.

2.2 Your membership will renew each month on the same calendar date you signed up – i.e. if you signed up on 15th May, it will renew on 15th June & payment will automatically be taken on your renewal date.

2.3 If you would like to cancel your subscription, you can do so via your [Account](#). Please note 24 hours notice is required before your renewal to ensure your payment can be cancelled in time.

2.3 You will receive an email confirming your subscription cancellation date within 24 hours. Your cancellation date will be at the end of your billing period.

2.4 Once your membership has expired, you may renew at anytime by logging back into your account.

2.5 Bop Tots may still contact you following cancellation of membership in accordance with our privacy policy

## **3. Consumer rights**

3.1 You have the right to cancel your membership with us within 14 days of your original signup. This does not apply to subsequent renewals. From time to time certain promotions may have different requirements regarding the cancellation period. Specific cancellation policies will be detailed throughout the purchase process for example Free Trials.

3.2 If you cancel your membership within the 14 day cooling off period you will be charged a pro-rata fee for costs incurred during your period of membership. Any refunds given under the 14 day cooling off period will be provided less this pro-rata fee.

3.3 Subject to any other statutory rights you may have, we do not provide refunds for any cancellations after the expiry of the

cooling off period. Access to member incentives will be removed immediately following cancellation if within the 14 day cooling off period.

#### **4. Payment and pricing**

4.1. The price of membership will be as quoted on the website at the point of signing up, except in cases of obvious error.

4.2. We may change the price of membership from time to time; however, any price changes will apply no earlier than 30 days following notice to you via email.

4.3. Payment is by credit or debit card, processed by Stripe ([www.stripe.com](http://www.stripe.com)) . We will charge your card at the point you sign up to become a Bop Tots Club Premium Member, and then on subsequent renewal dates for the lifetime of the membership until cancelled.

4.4 The Bop Tots Club reserves the right to withdraw access to the membership website area in the event of failed or non-payment

4.5. The Bop Tots Club accepts no liability for banking charges incurred as a result of the membership fee being taken
